

## Arizona Tax Credits

The state of Arizona offers tax credits you may wish to participate in:

### 1) Qualifying Charitable Organizations

An individual income tax credit is available for contributions to Qualifying Charitable Organizations that provide assistance to residents of Arizona. The maximum credit you can receive depending on your filing status is **\$400/\$800**. **Donation Deadline Date is 4/15/18**.

Examples of Qualifying Charitable Organizations:

- East Valley Adult Resources
- United Food Bank
- Habitat for Humanity
- Other Organizations:

- Boy Scouts of America

### 2) Qualifying Foster Care Charitable Organizations

An individual income tax credit is available for contributions to Qualifying Charitable Organizations that provide foster care to children in Arizona. The maximum credit you can receive depending on your filing status is **\$500/\$1,000**. **Donation Deadline Date is 4/15/18**.

### 3) ECA – Extracurricular Activities (Schools)

An individual may claim a credit for making contributions or paying fees to a public school for support of extracurricular activities or character education programs. The maximum credit you can receive depending on your filing status is **\$200/\$400**. **Donation Deadline Date is 4/15/18**.

### 4) Contributions to School Tuition Organizations

An individual may claim a credit for making a donation to a School Tuition Organization for scholarships to private schools. The maximum credit you can receive depending on your filing status is **\$1,089/\$2,177**. **Donation Deadline Date is 4/15/18**.

### 5) Arizona Military Family Relief Fund

An individual may claim a credit for making contributions to the Arizona Military Family Relief Fund. The donations support veterans and their families in the state of Arizona. The maximum credit you can receive depending on your filing status is **\$200/\$400**. **Donation Deadline Date is 12/31/17**.
